

Safety Information During Your Visit

Traffic Regulations in the Factory



The “drive slow dictate” applies if driving is approved on the factory premises. The maximum speed is 20 km/h. Hazards when reversing are to be ruled out.



In general, there is heavy traffic on the factory premises.



Please be considerate. Only use the entrances and exits as well as sidewalks that are intended for the movement of people.



Park your vehicle in the factory parking lots or in an allocated parking space. Fire department access roads, fire extinguishing equipment, transformer stations, traffic routes, emergency exits and cable covers are generally to be kept clear!

General Safety Rules



Every visitor / business partner has to sign in before entering.



In the production areas open shoes or short trousers are not allowed.



It is not permitted to bring and drink alcohol or to consume intoxicants on the factory premises.



Smoking bans are to be observed.



In general, a quick first-aid is mediated by the doorman around the clock.

Personal Protective Equipment

We want everyone who works with and for VDM Metals at the Unna location to return home safely and healthy. We are therefore constantly improving our safety regulations.

Please note that safety shoes type S3 are required in the production areas of the Unna location (applies to all employees of the VDM Metals Group as well as their service providers and/or subcontractors).

You are obliged to wear the following personal protective equipment during your stay in the production areas of VDM Metals GmbH:

- Hard hat (activity-related)
- Safety shoes type S3 or S2 with ankle protection
- Safety goggles (activity-related)
- Reflective vest (delivery and return traffic)

High visibility vest and safety shoes must be worn when leaving the vehicle! (delivery and return traffic)



There is a general photography and filming ban (also applies to cell phones) on the entire factory premises. Video recorders and cameras may not be kept with you.



For security reasons, the entire factory premises are under video surveillance.

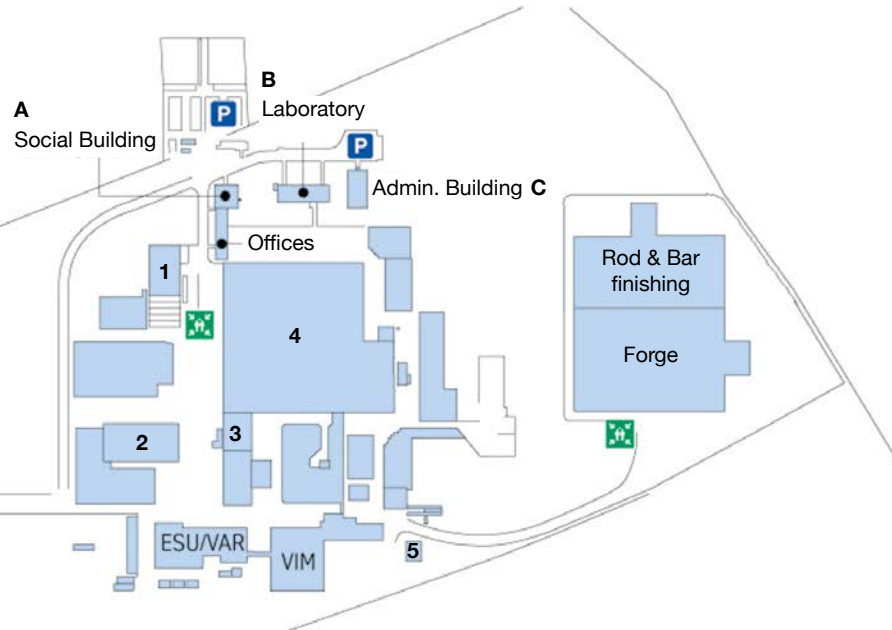

Safety Rules for External Companies



Always be attentive during operation and anticipate errors of other people. External companies with a work order may only perform their work with written instruction from the external company coordinator.



A permit is required for work with a fire hazard. Plant security is to be informed in the event of damage to our facilities.



Once the work is finished, the construction site is to be left clean and tidy. Waste must be taken back with you or disposed of at VDM by arrangement.
